I was deployed to Butterworth Malaysia from June 1988 to September 1988 as a Rifleman in 2 section 7
Platoon Charlie Company 8/9th Royal Australian Regiment, Our primary tasks were to provide security for the Butterworth airbase, to train alongside the Malaysian Armed forces and the New Zealand armed forces. We were also rotated through as a quick reaction force (QRF)at Butterworth armed with live ammunition for when the need arised for an enemy attack. We also patrolled Northern Malaysia for what we were told was armed insurgents entering Malaysia. During this time i carried a M16 assault rifle and the rest of the section carried their normal small arms weapons for operational service. The company's heavy weapons were also readily available along with ammunition on base. Prior to deployment to Malaysia we trained at the Land Command Battle Centre jungle warfare in Tully North Queensland. Also completing training exercises in the Shoalwater Bay training area.
