I was a young Infantry Soldier posted to Charlie Company 3RAR Based at Woodside South Australia. In 1979 Bravo Company we're heading to Malaya to do a tour of duty at Butterworth AirForce base and were looking for extra soldiers to bolster there ranks. I was offered and excepted a position as a rifleman to go to Butterworth with Bravo Company. I was young and green and did not know much about was was about to go on.

First up I was told you must be what was termed DP1 , what does that mean I ask, you must be physically fit ,medically fit, all your teeth must be good and all of your kit must be serviceable and correct for war service in the country you are going to.

So the next thing I know is I'm off to the dentist for a few visits until my teeth and gums are past as in good condition and DP1 , next I am receiving vaccinations for every known and probably unknown ailment going. Then comes all the physical tests.

Once all that is done we are all lined up at the Q store being issued all the items we might need in battle.

Next is the lecture room where we are given a detailed description of our tasks as a ready reaction force for the protection of the RAAF and Butterworth Airforce Base.

We are told that we will be armed with live ammuniton and will be given rules of engagement, at this point we are reminded that this is NOT a training exercise , we are there to protect assets and people associated with the base and that we have the right to use lethal force if necessary to achieve this.

Then came the came the conduct and discipline talk were we are told that as we are on war like service we will be charged under the " Whilst on war service act and that penalties will be a lot tougher and much more expensive. So by now I am thinking to my self " this is not a game this is real and I had better wake up to myself.

Then to reinforce it more we are ask if we have a last will and testament and that if we had to bring it so as 3RAR could view it and keep a record of it, I was 20 years old why did I need a will I thought" well they soon set

me straight with " You need all your home affairs sorted in case you don't come home , that's why they have coffins at the base.

Then we were taught how to say stop or I will shoot in Malay "Berhenti atau saya Akan tembak ".

Next thing I'm on the plane to Singapore, we get off the plane and are quickly put through customs loaded on trucks and off to Butterworth I remember being very unsure at the airport I had never seen anything like it men in uniforms armed with sub machine guns everywhere you looked , it was scary for a young green soldier.

It's not long before we are all settled in at AirForce Base Butterworth and I work begins . I remember our first night on Duty as QRF ( quick reaction force) I was nervous I didn't know what to expect but I did know that I was ready and I knew that the rest of the team had my back as I had there's, we had several call outs on that first night we never knew if this one was for real or just a test so we treated them all as real , I remember thinking I have live rounds and my weapon is in the state of action there are no range flags and there are personal planes and vehicles in front of me and all around me , this is real and my responsibilities are huge.

The debrief after our first night wasn't great apparently the AirForce commander said that we were not quick enough and that if the base was attacked he would lose planes, needless to say we soon learnt to be a lot quicker.

Mostly I carried an SLR and sometimes an m16 but I liked the SLR because I knew it had great stopping power , The CPLs who were Vietnam Vets would always tell me m16s didn't stop the enemy like an SLR.

On one occasion though I had to swap my m16 for a 9 mm pistol because I had to clear an aircraft hanger full of mirage fighter jets, I remember thinking if I come across a CT I'm sure he wouldn't be carrying a nine mil but the AIRFORCE said it would be easier to fix a plane hit by a 9 mm than it would to fix the damage from a 7.62mm nato round..

Now I wasn't a ranking soldier in the know of everything that was going on but I was a soldier sent to another country to do a job because there was a threat and the threat was real , I remember reading a local Penang paper

where the headlines were " police shoot dead suspected CTs in car after they did not stop at check point".

Malay Helicopters would often land and reportedly unload wounded on the Air strip.

At all times from first preparing to go To RCB Malaya ,serving at RCB Malaya and returning home from RCB It was drummed into us that this was real the threat was real and that we were on war like service .

Our presence alone was a deterrent but if the base was attacked we were there to do a job and we would have killed if necessary to protect base and personnel.

It wasn't a game, it wasn't training it was a seen threat by the Malaysian government and the Australian Government , The Malaysian Government even offered us a medal but our Government knocked it back because they didn't want to admit the truth .

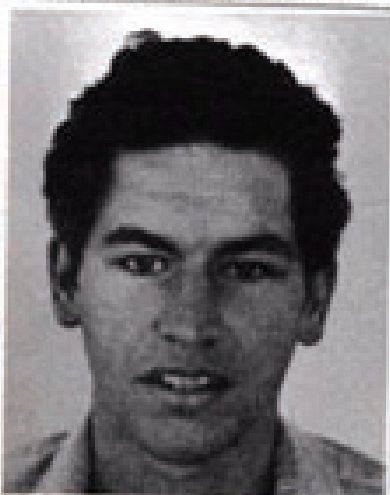

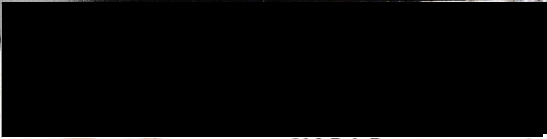
