In Malaysia between 63-64 ,I had been on Special Service-War Service -ASM for Singapore and also ctive Service from 1964 on wards to the end 1965! I do know a little about soldiering ,awards and different types of service! In regards to the RCB,I consider the situation to Malaysia ,apart from the Indos landing in Kesang ,which I was in...we done the same thing as the RCB! I understand the classification of the type of service one is on, THE RCB should have been on Active Service, because Malaysia was on Active Service. In 1973-74-75 and 76 ,their Infantry was in battle on the border of Thailand,very close to the Airbase we were protecting! I seen politics in 64-65 when Australia tried to renig on sending 3RAR to Sarawak! This is the reason that the RCB was cleverly covered by protecting our assets and training with Malays .The Vietnam war just over ,the Government was not keen to tell the media very much about sending a force into a Country who was fighting

terrorists. This recognition of RCB was also halted and refused by a few Ministers in the Liberals(Nats AS WELL! Probably like Medical Specialists who all stick together when things are tight! I am very happy to be interviewed in person about my statement. I do not want DVA benefits for the RCB and I have 9medals,however my fight is for FAIRNESS and for the young soldiers at the time to gain something out of the work they put in. 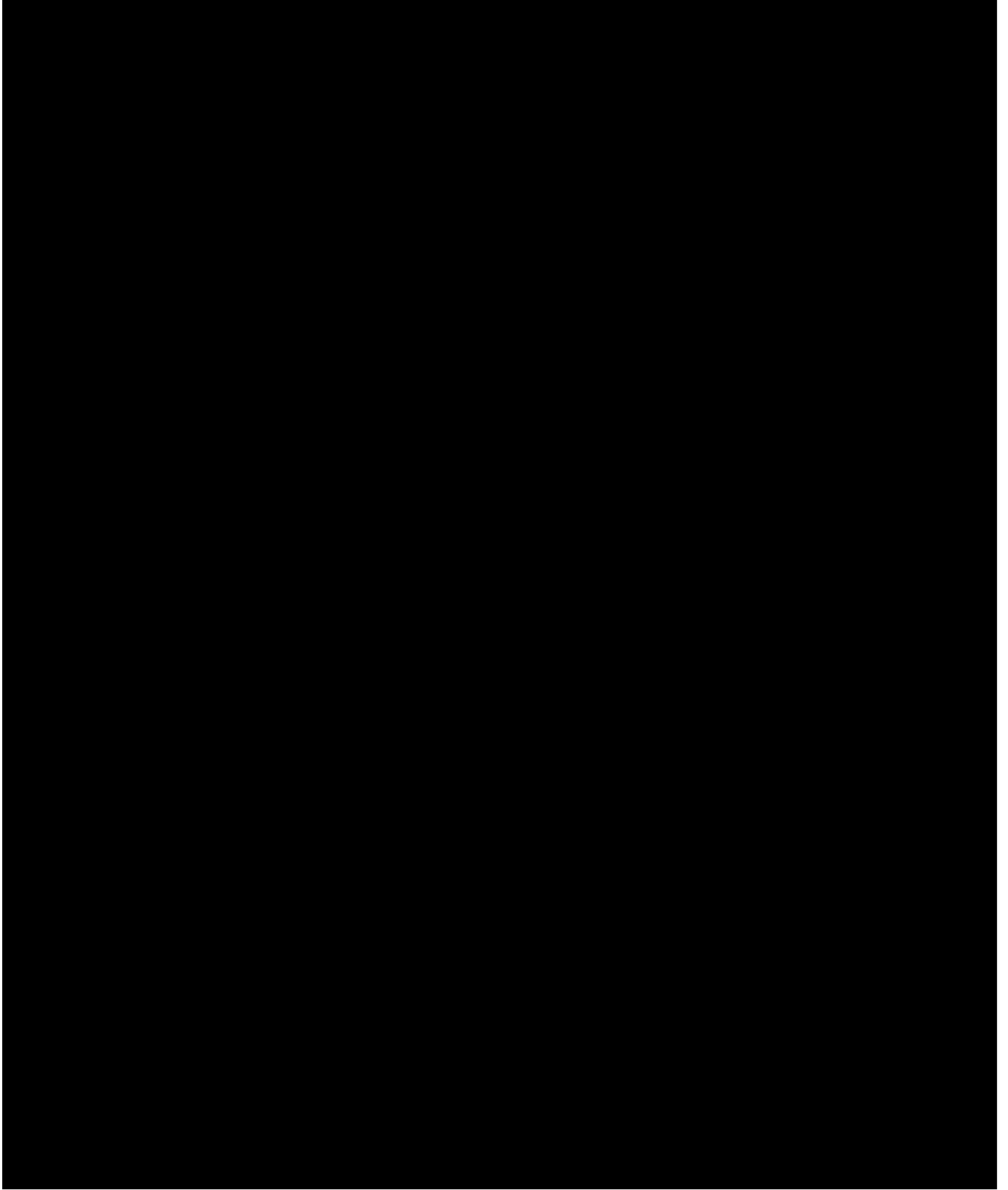
